The proposed contract holder is the company or individual to whom the contract may be assigned. The contact name and information needs to be the person responsible for handling the assignment of the contract. The state of incorporation is the state in which your company is legally established.

To ensure information is sent to the correct locations, please identify an overnight address by either checking Same as Correspondence Address, Same as Billing Address, or completing the Overnight Address fields. Please do the same with the Billing Address.

Section 3: Requestor Information

Requestor information is your information. The Effective Date of Assignment is the sale date or the date the Proposed Contract Holder would like to begin using the property. Please supply the reason for assignment (i.e. sold property).

Priority Handling: Please check the priority handling check box and include the total assignment cost.

Section 4: Contract(s) to be Assigned

If more than 5 contracts need to be assigned, please supply an attachment with the contracts and the required information. Contract type is an identification of the contract such as land, pipeline, wireline, road crossing, sidetrack, track lease, etc. The CSXT contract number is the number we use to identify and file the contract.
